### **OAW Director's Report – JFI**

• Training program updates: There are two new lessons that have been published since last month: "Finding Flooded Cages with Mice or Rats" and "Methods of Identification with Mice and Rats"

• IACUC metrics: The metrics are posted under Supporting Documents in the meeting folder

• 4374-01: On December 30th, health checks were not performed in a lab managed housing space with frogs (xenopus tropicalis; housed in a recirculating system). The missed day coincided with the snowstorm in Seattle. The lab's usual contingency plan fell apart, as multiple lab members were not able to safely travel to campus due to the weather or were unable to come to campus due to COVID quarantine. Although no health check was performed, no feeding days were missed (this species of frog is only fed 3 times per week). There was no apparent harm to the animals as a result of this event. This was identified on January 14th during an IACUC site visit.

The PI is deeply apologetic for the oversight, and the group is currently working with their OAW liaison to strengthen their lab's contingency plan to ensure appropriate coverage in the future.

#### • This has been reported to OLAW.

• The PI reached out directly to the IACUC Chair expressing chagrin. Lab members were not able to come in due to snow/ice storm and COVID positive staff. Vet Staff should have been informed so the daily checks could have taken place.

 $_{\odot}$  The Committee discussed whether a Letter of Counsel was appropriate and whether there was an Emergency/Contingency Plan in place. A letter was not deemed necessary.
